Introduction:

The Combined Australian Netball Association (CANA) identifies that risk management is a major component of the preparation for possible events in advance, rather than waiting until they happen. The Risk Management Project is perhaps that most effective tool in the governance structure of CANA and increases the odds for mitigation and being prepared for issues. This plan will assist in predicting budgets and scheduling, even when changes occur or unpredictable events take place.

This plan ensures a heightened understanding of the identified risks. This will allow the CANA Board and any future Host Association to plan future carnivals and CANA events.
